There was obviously some needle between the two camps which is a pity because both teams were managing to play entertaining football without this sort of thing.

Just before half-time desperation worked its way into the Luton defence and Barber, with his ten team mates lined up under the bar behind him, had to make an amazing save to a free kick from the penalty spot by Bolton.

It was Scanlon who struck for County, helped by a mistake by Anderson. The controversial goal capped a frenzied burst of activity by the County winger.

The Town were unchanged with Alan West again missing because of a shoulder injury. So, like last week, Jimmy Ryan continued in midfield. The only alteration on the Luton sheet was at substitute where Jimmy Husband came back for his first senior appearance of the season.

County have been able to field the same side for the past six matches and this was made possible today by the fact that long-serving centre half David Needham recovered from a strain during the week before being announced fit.

The match could have begun disastrously for Luton. A long ball from County crossed the corner of the Luton penalty box and with Buckley not bothering to feed it to his goalkeeper, Barber picked the ball up from outside the box to give the Nottingham club a first-minute free-kick.

This was knocked across by Probert and though Paul Futcher managed to head clear, he collected an accidental kick from centre-half Needham and had to have some treatment.

And it was Needham again who did well to take the ball from under the nose of Anderson in the County penalty area after King and Jim Ryan had created the opening.

Luton got another bite of the cherry but Alston's shot was wide.

That man Needham was there again a couple of minutes later when he headed back a huge throw from Barber and the Luton goal-keeper was forced into making a brave save at the feet of Carter.

After Aston had won a corner, which was cleared after Ron Futcher had forced McManus into a fumble, fumble, County hit back again but a long centre from full back O'Brien caught Bradd offside.

After being fed by a fine pass from Alston, Jimmy Ryan mucked up a good-looking Luton attack by knocking the ball too far forward allowing Needham to clear.

After further flurries of Luton effort, County hit back with a positive shot from Bolton but it lifted over the Luton crossbar.

Aston, who had been injured earlier in the game, had to leave the field after 32 minutes to make way for substitute Jimmy Husband to make his first team appearance of the season.

Ron Futcher tried to turn an accidental trip into a penalty after going over the leg of Richards, but in spite of the Luton man's protests, the referee would have none of it.

A minute later a rare defensive mistake by County let in King and Ron Futcher. Futcher took the shot but it was half blocked and bobbled on to the 'keeper.

The match soon got back into its pattern. A good dash down the left by Buckley was stopped by the Nottingham defence, and at the other end John Ryan did a good job in preventing Scanlon getting through.

Then a couple of Andersonprompted moves brought further hope for the Town, but first King and then Alston ran into a wall of trouble.

With some help from Ron Futcher it became Anderson's turn to break through but after a promising run he was stopped by Stubos.

Some indecision by Buckley let Carter get in a narrow-angled shot which Barber managed to divert for a corner. Fortunately this, and another flag kick which resulted from it, did not cause the Luton defence much problem with Faulkner and Jimmy Ryan sorting it out.

Anderson was playing well in midfield but Luton still found it hard to break through. Faulkner tried a long ball into the goalmouth, but it was much too hard with no Luton player in range.

And seconds later, Faulkner was in action again, this time

helping Barber who had had to run out of his area to stop a left wing raid and ther experiencing the ball passing him on its way into an empty goalmouth.

But it was certainly a dingdong match. Ron Futcher left the County defence standing with a 50-yard dash but his pass across the goalmouth, which beat goalkeeper Mc-Manus, was just wide of Kin,

Another Luton attastarted by Jimmy Ryan a furthered by Husband w wasted when King shot wifrom too far out.

The all-important goal can after 66 minutes when, after mistake by Anderson, Brad slipped a ball through to SCANLON who flicked it pass Barber into the Luton net.

The effort looked suspiciously off side but it was allowed and Faulkner received a talking to by the referee for arguing with the linesman who refused to raise his flag.
