A referee who lists conservation among his interests was clearly not in the mood to help preserve a place in the Premier League, nee First Division, which has been Luton's refuge for the past ten years.

Throughout the decade they have survived by the skin of their teeth, a trend set in 1983 with victory in the 85th minute of the last afternoon at Manchester City which sent City down, and Pleat on his famous arm-waving, jacketflailing run across a silent Maine Road.

The manager's walk to the dressing room after the 2-1 defeat at Southampton on Saturday was more circumspect. During it, he trudged past the statuesque figure of his goalkeeper Mervyn Day, hands on hips, shaking his head as Mr Wilkes and his linesman scurried past.

The first, pre-empted by a linesman waving as Day drop-kicked on the edge of his area, was debatable. The fact that he was fouled at the ensuing corner merely added to his anger.

Southampton manager Ian Branfoot, whose programme notes hammered the press for not condemning poor refereeing in Saints' games, will, one hopes, be reassured that Mr Wilkes comes

straight into that category. Luton were denied by means outside their control the victory that would have caused one or two more hearts to flutter at White Hart Lane. Tottenham are likely to survive, more because of the failings of others than through their own dismal form.

Pleat spent a couple of minutes in the referee's changing room before drawing a deep breath in the Southampton press room. 'I musn't be too hasty,' he said. 'I have always believed that referees and linesmen are honest people and it's unusual for a linesman to prosecute a 'keeper for coming out of the box. I think the referee would have found it very difficult to disallow the second goal.

'We're determined not to feel sorry for ourselves. There are
